Grande Prairie Women's Institute

On September 28, 1924 nine women met with Mrs. Beaubier, the Provincial President and Mrs. Stewart, Director for the Northern Division to discuss the forming of a branch of the Women's Institute in Grande Prairie.

Moved by Mrs. Jones, seconded by Mrs. McQuarrie that an Institute be formed in Grande Prairie.

Moved by Mrs. Graban, seconded by Mrs. McQuarrie that the Institute meet on the first Thursday of every month beginning Nov. 6, 1924

Mrs. Graban offered to act as Hostess for the next meeting.

Thursday, Nov 6, 1924

The President opened the meeting by reading the creed.

The minutes of the previous meeting were read and adopted.

Eight new members were enrolled.

Move by Mrs. Thompson, seconded by Mrs. Jones, that Mrs. F. Roberts act as director in place of Mrs. Shields who is moving away.

The following committees were appointed:

Moved by Mrs. Yule and seconded by Mrs. J. Thompson that Mrs. Jones act as convenor of the flower committee and take charge of the money.

Mrs. A. Forbes and Mrs. D. Patterson were elected auditors for the coming year.

Moved by Mrs. Bell and seconded by Mrs. Jones that a letter of sympathy be sent to Mrs. Reevely.

The question of holding a tea to raise funds was brought up but nothing definite was decided.

Mrs. Graban and Mrs. Yule were delegated to look into the case of Ronald Carruthers and if necessary report it to the proper authorities.

Mrs. Thomson reported the case of the Martelle child at Goodwin who is badly in need of an operation for a hair lip. Mrs. Thompson was asked to communicate with the parents to find out if they were willing to let the Institute take the matter up.

The meeting closed with the singing of the national anthem after which tea was served.

Meeting opened with reading of Creed. Minutes were read and approved.

It was decided to let the matter of Ronald Carruthers stand until further investigation could be made.

Mrs. Graban read and explained the program for the year as drawn up by the Program Committee.

The Subject of Demonstration Course was brought up. It was decided to ask for a Sewing course and the Secretary was instructed to notify Mrs. Clubine of the Lake Saskatoon Institute of our choice, and to add that if possible we would like a demonstrator who could teach basketry as well as the majority of our Institute members prefer basketry.

It was decided to meet at the President's on Friday evening to make paper flowers.

Moved by Mrs. McQuarrie, seconded by Mrs. Doran that accounts totalling \$1.65 be paid – carried.

The Treasurer reported a total of \$4.50 in the General Fund & 95¢ in the flower fund. Moved by Mrs. Reavely, seconded by Mrs. Bell that the Treasurer's Report be adopted as read. Carried. The Treasurer was instructed to buy a proper account book. Mrs. Lance Smith donated a file for the use of the Treasurer.

Moved by Mrs. Reavely, seconded by Mrs. Hacking that the President call a meeting for Tues night Jan. 13th to organize a Home Nursing class. Mrs. Reavely rescinded the motion. It was decided not to undertake this matter & to leave the matter in the hands of Miss Hibbs.

Moved by Mrs. Hacking, seconded by Mrs. Jones that we hold a tea on Saturday, Jan 17th. Mrs. Hacking rescinded the motion.

Moved by Mrs. Doran, seconded by Mrs. Lance Smith that all members contribute the sum of fifty cents toward the fund for the operation on the Martel child.

Roll call of officers answered by maxims.

Mrs. Fred Smith gave a number of delightful piano selections & Mrs. Reavely gave a series of interesting current events.

Moved by Mrs. Bell that we adjourn. Meeting closed at 10:10 p.m. with the singing of the national anthem.

At an executive meeting held immediately after the regular meeting, it was decided to hold the Feb, March & April meetings in the evenings instead of the afternoons.

Moved by Mrs. Thomson, seconded by Mrs. Jones that we make paper caps and sell them at the next hospital dance. Carried. Mrs. F. Roberts, Mrs. Jones, Mrs. Reavely, Mrs. D. Patterson, Mrs. Fish, Mrs. Forbes and Mrs. Cunningham volunteered to aid in making the caps.

Move by Mrs. Thomson, seconded by Mrs. Wishart, that we put on a play, selection and date to be left to the following committee: Mrs. F. Smith, Mrs. Hacking and Mrs. D. Patterson. Carried.

The roll call of members was answered by quotations from great men. There were fifteen present.

Recess for a few moments.

A biography of Abraham Lincoln, written by Mrs. Yule, was read by Mrs. Hacking. Miss Viola Carter gave a delightful reading.

Moved by Mrs. Hacking, seconded by Mrs. Thomson that a bill of 35¢ for an account book at James' Drug Store be paid. Carried.

Moved by Mrs. Thomson seconded that we adjourn.

Meeting opened at 8:15 with the reading of the Creed.

1st Vice President Mrs. J. Thompson occupied the chair, the President being absent through illness.

Minutes of previous meeting were read & approved.

The Treasurer reported the sum of \$54.06 in the General Fund. Ten dollars of this being talent money made by the President alone and 29.75 from the sale of fancy paper caps at hospital dance. In the Flower Fund the Treasurer reports (transcriber note: missing text?) Moved by Mrs. Bell, seconded by Mrs. Hacking that the Treasurer's report be adopted as read – carried.

Mrs. Fred Smith gave a delightful talk on the life and works of Franz Schubert, illustrated by piano selections from his work. Miss Norine Harmer sang two of Schubert's famous songs very delightfully.

Letters from Miss Macmillan asking for information as to number of women farming on their own in the district and from Mrs. McGregor Smith, on the resolution submitted by FWIC on Home Economics with regard to establishing a Home Bureau at Ottawa were read.

The committee reported on the play selected to be put on. Mrs. Reavely & Mrs. Yule were appointed directors for the play and they, along with the committee who had selected the play, were to pick out suitable persons to take the different parts.

Moved by Mrs. Hacking, seconded by Mrs. Patterson that the Institute take up the matter of the musical contest for the Grande Prairie District and put up a shield for the winning chorus. The winning group also to be taken to Peace River to enter the musical festival there about May 24. The contest is to consist of group singing in one & two parts and solo singing.

Moved by Mrs. Jones, seconded by Mrs. Forbes that it be left to the executive to find out particulars about the shield and to order a suitable one.

Three new members were added to the roll.

Moved by Mrs. Bell that we adjourn.

Moved by Mrs. Bell that part of the proceeds from the entertainment be given to Board of Trade to help defray expenses of delegates – carried.

The Executive reported that a shield had been ordered thru Mr. Watcher for the winning chorus. The shield will cost in the neighbourhood of ten dollars.

Correspondence was read by Sec. re: the sending of a delegate to the convention but no action was taken as we will get the report through Mrs. Clubine.

Roll was called. Owing to an epidemic of sickness among children the attendance was very low.

Moved by Mrs. Fish, seconded by Mrs. Reavely that we sell tickets for the concert and that the bills be paid by the executive, also that final arrangements be left to the executive.

Moved by Mrs. McQuarrie that we adjourn.

The meeting closed at 10.

Report on expenses etc of basketry class were read. It was found that while there was quite a bit of reed on hand five baskets were still unfinished and more reed of no. 1 and no. 3 would be needed which the Secretary was instructed to order. There being \$4.53 on hand, having been paid for reed.

The subject of continuing the class was brought up for discussion. Moved by Mrs. Bell, seconded by Mrs. Jones that the class be continued in the evenings until all reed on hand was used.

The Secretary was instructed to report to Moyers the unsatisfactory condition of the tray bottoms sent. and to order the reed.

The Treasurer reported \$93.83 on hand in general fund. 95¢ was added to flower fund. Moved by Mrs. Bell, seconded by Mrs. Wishart, that the Treasurer's report be adopted – carried.

Moved by Mrs. Jones, seconded by Mrs. Wishart, that a letter of thanks and appreciation by sent to Miss MacMillan, especially commending Miss Tillie on the excellent work accomplished by the class and on her capable management of the class. Also, that letters of thanks be sent to Dr. Forbes for donation of \$10 and to Mr. King for use of his room for the class.

Mrs. Bell was instructed to find out from Mrs. Clubine when it would be convenient for the GPWI to take a picnic out to her farm and to hear from her a report of the convention.

Three new members were added to the roll. Mrs. Lawlor, Mrs. Pearsey and Mrs. J. McPhee.

The September meeting which was to have been held at Mrs. Forbes' was changed to Mrs. Jones' house, Mrs. Reavley assisting.

Moved by Mrs. McQuarrie, seconded by Mrs. Jones that the Secretary order stationery with letterhead given name of Institute and officers if it could be secured at a reasonable price.

A vote of thanks was offered Mrs. Clubine for her kindness in giving us the report and also for her hospitality.

The meeting closed with the singing of the national anthem after which the hostess served a delightful lunch.

Donation of clothes for Martel children discussed. Ou was Anyone having anything to donate to leave it with Mrs. Graban.

Moved by Mrs. McQuarrie that we adjourn.

Meeting opened at 3.40 with reading of Creed.

Minutes of previous & special meeting read and approved.

Secretary read a letter from the Treasurer, Mrs. Jones, containing her resignation as she is leaving town. Mrs. Jones' resignation was accepted and Mrs. A. McQuarrie appointed for the remainder of the year.

The Treasurer's report showed \$33.65 in general fund and \$3 in flower fund, but the cheque bill for \$34.50 due the hospital had not been paid. After this bill was paid our balance would be practically nil.

Ways & means of raising money were discussed. It was decided to hold two silver teas in the near future.

Mrs. Bell our delegate to constituency conference read her report. She also reported that the question of capital tax was discussed. Miss MacMillan advised having the Secretary write to Mrs. Rogers for a ruling.

The secretary read the reports of the regular March meeting and of the special meeting of the Ex. held March 30.

Mrs. Bell reported of hampers packed for the four families of settlers.
